Comments on Regulation, if any:

The minister of justice is about to make some changes in the law. Some companies are getting permission advertising with legal advice, and without professional liability insurance. Here included detective bureaus. This will open for new possibilities.

The purpose is to give firm of lawyers competition on there high costs

Further detective bureau previous was a subject to the police to be controlled of.

The new thing is that detective bureaus is subject to "consumers' ombudsman" (consumer watchdog) on equal terms with other companies.

We see this as an advantage and an unspoken careful acknowledgement of our branch.

The bill is not yet carried out.
