>Association Description:

The Detective Chamber of the Republic of Slovenia unites and represents the private investigators in Slovenia. It is the link between the detectives, government and public. It gives and takes away the licences, manage directory of members and supervises the work of members. With licensing regulator (Ministry on the Interior) defines the contents of private investigator exam, Code of ethics, prepares the modifications and completions of Private Detective Services Act.

>Association Activities:

In addition to tasks, specified by law, The Detective Chamber of the Republic of Slovenia once a year hosts Probono day of detective services, where private investigators give free advice and answer any questions people have regarding detective services.

Once a year The Detective Chamber of the Republic of Slovenia also hosts Days od detective services, where we invite different experts for conducting lectures and training for our members. We also participate in career fairs, where we promote detective services and invite new members to consider private investigators career.
